This procedure outlines safe handling procedures and practices that the club believes minimizes risks associated with fueling of club engines at the Dinghy Sailing Centre in Broadmeadows.

## 1. Safety

- Only members who have attended a familiarization session and signed that they have read, understood and will follow this SOP are permitted to handle fueling of club boats.
- The primary fuel used in club boat engines is petrol. This is a flammable, and highly flammable when in vapour form. Judgement and utmost care must be taken at all times.
- At no time is anyone under the age of 16 permitted to handle fuel or refuelling of engines.
- Responsibility for safe fuel operations at BM:
  - Centre Principal
  - Senior Instructor
  - o OD
  - o Bosun
  - Senior committee / Class Captain on Site
  - o Coach/ Instructor working on site


# 2. Re-stocking of fuel

- Petrol purchased and transported in a private car is a potential hazard and there is a limit of 20 Litres that can be transported safely in an appropriate container in the boot. Volunteer members need to be aware of this risk.
- For quantities greater than 20 Litres the club is providing a dedicated trailer/ mobile fuel bunker. This has the scope to transport appropriate metal jerry cans which can be filled in the trailer and will minimize lifting and manual carrying of fuel.





- Fuel is purchased from any nearby filling station by authorized adult club members using the "Pleo" fuel card. A list of authorized users is with the Centre Principal and Club Bosun.
- Only fill fuel containers to half full.
- The trailer can be used to drop off 3 fuel cans into Bunker 2 and then 3 cans left in trailer at Bunker 1 location.
- Expected frequency of Re-stocking:
  - Low season every 2 weeks
  - Mid season (Tuesday/ Thursday/ Sat sailing) weekly
  - High season/summer courses every 5 days



To minimize quantities of fuel stored at any one location and minimize the movement of fuel containers, the following will apply:

 Plastic Fuel tanks / fuel line /water separator to be secured on board boats in ventilated storage containers.

- There will be two storage areas for fuel for the purpose of refuelling the fuel tanks in boats
  - Bunker 1: mobile fuel bunker parked in marked area to east of pen
  - Bunker 2: A small fuel bunker located to west of pen.
- Maximum 60L petrol storage at each fuel bunker
- The locations have been selected to serve nearby boats
- Containers will have colour coded handles clearly indicating which bunker it belongs to
- Fire break needed around each storage container location.
- Sand bucket availability to absorb spills and to help in event of fuel fire.
- Locations to be kept clear to enable rapid escape routes

Total amount of petrol on site to use the following guidelines

- A maximum of 100 Litres spread across storage locations in the pen for racing & coaching season
- A maximum of 200 litres for summer course season

# 4. Re-fuelling Boats

- o Refueling done adjacent to boats in a controlled manner
- Only to be done by over 16's who have demonstrated competence and have signed off SOP
- o supervised by a competent adult (Race officer, etc)
- No smoking / naked light / use of electrical cables/ power tools
- o refuel boat tanks before boat usage (engine will be cold)
- Refuelling done from jerry cans with proper fill attachment
- Only fill fuel tank to half full
- Bunker 1 jerry cans to be used for boats in east end of pen.
- Bunker 2 jerry cans to be used for boats in containers at west end of pen
